Students choose three optional courses per semester.

Students of one specialization may choose optional modules offered under the other.

A student choosing 3 out of the 4 courses per semester from the same area acquires an additional specialization.

## Eligibility

To be eligible for admission, prospective students must hold a Degree in Law. The Steering Committee may also accept a first degree in a field other than Law, provided that at least some of the courses taught are related to the LL.M. Programme.

## Admission criteria

The selection procedure is based on an assessment of each application and a personal online interview with the Admissions Committee.

Only candidates who meet the admission requirements will be invited to interview.
