Anastasios Gourgourinis is an Assistant Professor of International Law at the School of Law of the National and Kapodistrian University of Athens and the Athens Public International Law Center (Athens PIL), a Research Fellow at the Academy of Athens, and a membre associé of the Centre de Recherche sur le Droit des Marchés et des Investissements Internationaux de Dijon (CREDIMI), Université de Bourgogne. Anastasios is the academic supervisor of the annual Athens Summer Law School on International Investment Law, coorganized since 2016 by ELSA Athens and Athens PIL. Anastasios is also a practicing lawyer with the Athens Bar Association in Greece, specializing in sustainable trade & investment, public law, corporate law, as well as arbitration and adjudication proceedings. In the past, Anastasios served as Special Legal Advisor at Greece's Ministry for Development and Competitiveness, and the Ministry of State, as well as Rapporteur and Secretary of the Scientific Council of the Ministry of Foreign Affairs.




