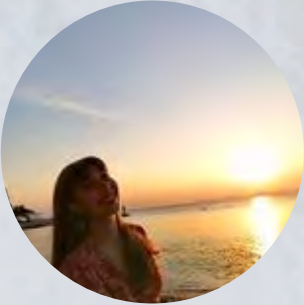

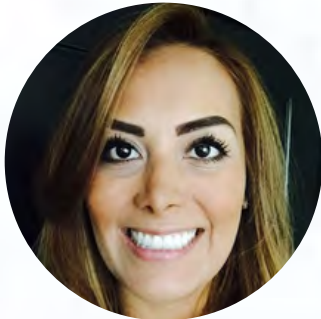

Gloria Alvarez is an international academic on international dispute resolution, energy and investment law. She has in-depth knowledge of commercial law in civil and common law systems, acts as legal expert and independent arbitrator (ICC, ICSID and LCIA experience). She has published extensively on topics of international arbitration and energy law.



CLAUDIA ANNACKER

Claudia Annacker is a partner at Dechert LLP in Paris. She focuses her practice on international arbitration and public international law matters, in particular investor-State disputes, inter-State disputes, disputes involving international organizations, and human rights cases. She has represented States and sovereign and private investors in more than thirty investment arbitrations. Holding a Ph.D. and *venia legendi et docendi* (habilitation) in public international law, she regularly advises States, State entities, international organizations and multinational corporations on public international law matters. Dr. BEN HAMIDA authored more than 80 publications in the Arabic, French and English languages. He is a regular speaker at conferences, seminars, roundtables and other fora on topics regarding dispute settlement, and visiting professor in more than 70 countries.

Dr. Christina Binder, E.MA, holds the Chair for International Law and International Human Rights Law at the Bundeswehr University Munich since April 2017. Before, she was University Professor of International Law at the Department of European, International and Comparative Law at the University of Vienna and Deputy Director of the interdisciplinary Research Centre “Human Rights”. She is member of the ILA Committees on the Implementation of the Rights of Indigenous Peoples and on Human Rights in Times of Emergency. Christina is member of the Executive Board and former Vice-President of the European Society of International Law (ESIL), was member of the Executive Board of the European Inter-University Center for Human Rights and Democratization (EIUC) (2016-2019) and is member of the Council of the Global Campus of Human Rights since 2019. Her research focuses on a number of public international law issues, including human rights, the law of treaties, international investment law as well as international environmental law. She is co-editor of the *Zeitschrift für Menschenrechte*, the European Yearbook of International Economic Law and of the Hungarian Yearbook of International and European Law and has widely published, in edited volumes and in peer-reviewed journals. Christina also served as legal and electoral expert for EU and OSCE/ODIHR election observation and assessment missions in several countries. She likewise acts as electoral expert for the Council of Europe Congress of Local and Regional Authorities and as external consultant for law firms in investment proceedings.
